



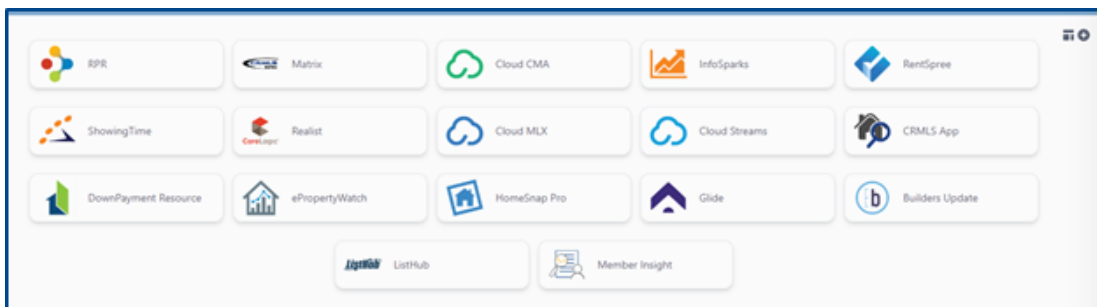

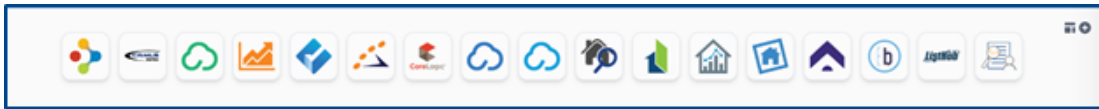
No two real estate professionals are the same. Everyone has their own approach to serving their clients. So, shouldn't your Dashboard be as unique as your business?
