### **Important alerts and messages all in one Notification Center**

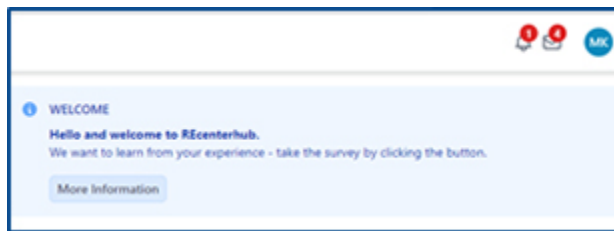
When you have one email address for your leads, one for compliance, one you hardly use, and one you keep forgetting about, it adds up to confusion and wasted time searching through all your inboxes.

When you log in, you'll see your communication tools in the top right corner of your screen.



Clicking the **Bell Icon** will take you to you all the messages and alerts from CRMLS and/or your Association – anything from informational updates to outages.

Your messages are also color-coded for your convenience:

<b>Warning (Red)</b>	Outages, issues, high priority messages
<b>Maintenance (Yellow)</b>	Vendor updates, new products, launches
<b>Notice (Green)</b>	Announcements, events, rebranding, PSAs
<b>Informational (Blue)</b>	General messages and news

The **Envelope Icon** will take you to all your communications from the CRMLS teams, including marketing, compliance, education, sales, and specific emails such as Broker Reports. You will still receive these at your roster email for your records.

Everything in your Notifications center is sortable and searchable, helping you easily find and access the communications you're looking for.
