What happens when a listing's "Estimated Close Date" passes? The MLS system automatically classifies it as "Auto Sold" – but Auto Sold listings don't always have the correct information! To preserve the accuracy of MLS data, those listings need to be updated with the proper information within two (2) days to avoid a violation.
